## **Coupons for Overseas Military Personnel**

If you have a computer and internet connection, go to <a href="www.martinsloane.com">www.martinsloane.com</a>. On this website you will find a category way down low on the first page titled "Please Lend a Helping Hand." When you click on that site, you will get the most current list of military commissaries located all over the world that are accepting unused coupons.

These commissaries stock thousands of national brands we buy here in the States. So, if the coupon is a national brand (especially baby products) send it. When the coupons are received, volunteers sort and distribute them, or put them in coupon exchange boxes. Please note that military commissaries will redeem these coupons up to **SIX MONTHS** after they have expired.

The Postal Service offers a "flat rate" priority mail box for \$7.70. You can fill it with as many coupons as you can, regardless of the weight.

<u>Important Postal Note</u>: The U. S. Postal Service does not accept mail addressed to "any soldier" or something similar (often used in previous times to send holiday greetings). If an address below shows the name of a person, use that name as the first line of your address. You can also use the name of an organization such as "Family Services", "Commissary", or "Defense Commissary Agency."

The Defense Commissary Agency (DeCA) operates nearly 280 commissaries worldwide that provide groceries to military personnel, retirees, and their families. Authorized commissary patrons purchase items at cost plus a 5-percent surcharge which covers costs of building new commissaries and modernizing existing ones. Shoppers save an average of more than 30 percent on their purchases compared to commercial prices – which results in an average savings of more than \$2,400 annually for a family of four.
